

**RESOLUTION NO. 2016-02**

**RESOLUTION BY THE CITY COUNCIL OF THE CITY OF LINCOLN,  
ALABAMA, ELECTING NOT TO EXERCISE ANY JURISDICTION OR  
AUTHORITY IN A PORTION OF THE POLICE JURISDICTION OF ITS  
NONCONTIGUOUS CORPORATE LIMITS**

KNOW ALL MEN BY THESE PRESENTS THAT:

WHEREAS, Act No. 2006-88, which was passed by the Legislature and became law in 2006, annexed certain property noncontiguous to the corporate limits of Lincoln, Alabama, and which has become known as Lincoln Harbor; and,

WHEREAS, by virtue of the 2010 Federal Decennial Census, the population of inhabitants of the City of Lincoln exceeded six thousand (6,000); and,

WHEREAS, Ala. Code 1975, Section 11-40-10(a) provides that the police jurisdiction in cities having six thousand (6,000) or more inhabitants shall cover all adjoining territory within three (3) miles of the corporate limits; and,

WHEREAS, Act No. 2015-361, which was passed by the Legislature and became law in 2015, grants to the governing body of municipalities the authority to elect by resolution not to exercise any jurisdiction or authority, including the assessment of any tax, in any portion of the police jurisdiction extended as a result of the non contiguous property annexation; and,

WHEREAS, the City Council of the City of Lincoln finds that it is in the best interest of the citizens of Lincoln, Alabama, for the City Council to elect not to exercise any jurisdiction or authority, including the assessment of any tax, in a portion of the police jurisdiction outside of the corporate city limits known as Lincoln Harbor, the said area being more particularly described hereinafter;

NOW, THEREFORE:

BE IT RESOLVED that pursuant to the authority of Act No. 2015-361, the City of Lincoln does hereby elect not to exercise any jurisdiction or authority, including the assessment of any tax, in any portion of the following described property constituting a portion of the police jurisdiction of the Lincoln Harbor corporate area of the City, to-wit:

The Southwest Diagonal Half of the Southwest Quarter of the Southeast Quarter of the Northeast Quarter (SW Diagonal 1/2 of SW-1/4 of SE-1/4 of NE-1/4) of Section 4, Township 18, Range 4 South

The Northeast Quarter of the Southeast Quarter (NE-1/4 of SE-1/4) less the Northeast Diagonal Half of the Northeast Quarter of the Northeast Quarter of the Southeast Quarter (NE Diagonal 1/2 of NE-1/4 of NE-1/4 of SE-1/4) of Section 4, Township 18, Range 4 South

The Southwest Quarter of the Southwest Quarter (SW-1/4 of SW-1/4) of Section 3, Township 18, Range 4 South

The Southwest Diagonal Half of the South Half of the Northwest Quarter of the Southwest Quarter (SW Diagonal 1/2 of S-1/2 of NW-1/4 of SW-1/4) of Section 3, Township 18, Range 4 South

The Southeast Quarter of the Southwest Quarter (SE-1/4 of SW-1/4) less the Northeast Diagonal Half of the North Half of the Southeast Quarter of the Southwest Quarter (NE Diagonal 1/2 of N-1/2 of SE-1/4 of SW-1/4) of Section 3, Township 18, Range 4 South

The Southwest Diagonal Half of the South Half of the Southwest Quarter of the Southeast Quarter (SW Diagonal 1/2 of S-1/2 of SW-1/4 of SE-1/4) of Section 3, Township 18, Range 4 South

The Southwest Diagonal Half of the South Half of the South Half of the Southeast Quarter of the Southeast Quarter (SW Diagonal 1/2 of S-1/2 of S-1/2 of SE-1/4 of SE-1/4) of Section 3, Township 18, Range 4 South

All lying and being in Talladega County, Alabama.






