

## **REGULAR MEETING OF THE CITY COUNCIL, LINCOLN, ALABAMA**

November 25, 2014

The City Council of the City of Lincoln, Alabama met in regular session in the Council Chambers at City Hall on Tuesday, November 25, 2014 at 5:00 p.m. Mayor Kitchin called the meeting to order and upon roll call the following answered present: Mayor Kitchin, Councilmembers Billy Pearson, Sadie Britt, Gwen Barber, Shelly L. Barnhart and Jean B. Burk. Invocation was given by Councilmember Pearson and Councilmember Burk led the Pledge of Allegiance.

Mayor Kitchin opened the Public Hearing to for the following proposed zoning changes: (1) Zone annexed property owned by Glen Gilbert Davis located at 180 Henderson Lane, Talladega to R-1; (2) Zone annexed property owned by John A. Burns and Lynn T. Burns located at 1140 County Park Lane, Talladega to R-1; (3) Zone annexed property owned by Ronald K. Brooks and Ammie H. Brooks located at 799 Blue Springs Road, Lincoln to R-1 and (4) Re-zone property owned by Bruce Griffin and Sarah Griffin located at 590 Dry Valley Road, Lincoln to SR. There were no comments from the public. Mayor Kitchin closed the Public Hearing.

Councilmember Britt made a motion to approve the minutes of November 12, 2014; second by Burk. The vote was Ayes: Britt, Pearson, Barber, Barnhart and Burk.

Mayor Kitchin presented Ordinance 2015-01 to zone annexed property owned by Glen Gilbert Davis located at 180 Henderson Lane, Talladega, Alabama to R-1. Councilmember Burk made a motion to accept the first reading as having been read; second by Britt. The vote was Ayes: Britt, Pearson, Barber, Barnhart and Burk. Councilmember Pearson made a motion to suspend the rules that would otherwise prohibit the immediate consideration of Ordinance 2015-01; second by Burk. The vote was Pearson – Aye, Britt – Aye, Barber – Aye, Barnhart – Aye, Burk – Aye and Mayor Kitchin – Aye. Motion passed unanimously. Councilmember Burk made a motion to adopt Ordinance 2015-01; second by Pearson. The vote was Ayes: Britt, Pearson, Barber, Barnhart and Burk.



Councilmember Britt made a motion to suspend the rules that would otherwise prohibit the immediate consideration of Ordinance 2015-02; second by Barnhart. The vote was Pearson – Aye, Britt – Aye, Barber – Aye, Barnhart – Aye, Burk – Aye and Mayor Kitchin – Aye. Motion passed unanimously. Councilmember Burk made a motion to adopt Ordinance 2015-02; second by Britt. The vote was Ayes: Britt, Pearson, Barber, Barnhart and Burk.

Mayor Kitchin presented Ordinance 2015-03 to zone annexed property owned by Ronald K. Brooks and Ammie H. Brooks located at 799 Blue Springs Road, Lincoln, Alabama to R-1. Councilmember Pearson made a motion to accept the first reading as having been read; second



Councilmember Britt made a motion to suspend the rules that would otherwise prohibit the immediate consideration of Ordinance 2015-03; second by Burk. The vote was Pearson – Aye, Britt – Aye, Barber – Aye, Barnhart – Aye, Burk – Aye and Mayor Kitchin – Aye. Motion passed unanimously. Councilmember Burk made a motion to adopt Ordinance 2015-03; second by Barnhart. The vote was Ayes: Britt, Pearson, Barber, Barnhart and Burk.

Mayor Kitchin presented Ordinance 2015-04 to re-zone property owned by Bruce Griffin and Sarah Griffin located at 590 Dry Valley Road, Lincoln, Alabama from R-1 and R-4 to SR. Councilmember Burk made a motion to accept the first reading as having been read; second by Barnhart. The vote was Ayes: Britt, Pearson, Barber, Barnhart and Burk. Councilmember Pearson made a motion to suspend the rules that would otherwise prohibit the immediate consideration of Ordinance 2015-04; second by Barber. The vote was Pearson – Aye, Britt – Aye, Barber – Aye, Barnhart – Aye, Burk – Aye and Mayor Kitchin – Aye. Motion passed unanimously. Councilmember Britt made a motion to adopt Ordinance 2015-04; second by Pearson. The vote was Ayes: Britt, Pearson, Barber, Barnhart and Burk.

There being no further business to come before the Council, Pearson made a motion to adjourn; second by Burk. The vote was Ayes: Britt, Pearson, Barber, Barnhart and Burk.
