

REGULAR MEETING OF THE CITY COUNCIL, LINCOLN, ALABAMA

November 27, 2018

The City Council of the City of Lincoln, Alabama met in regular session in the Council Chambers at City Hall on Tuesday, November 27, 2018 at 6:00 p.m. Mayor Watson called the meeting to order and upon roll call the following answered present: Mayor Watson, Councilmembers Sadie Britt, Jennie Jones, Shelly L. Barnhart and Joey Callahan. Councilmember Billy Pearson was absent. Invocation was given by Mayor Watson and Mayor Watson led the Pledge of Allegiance. Councilmember Britt recorded the minutes in the clerk's absence.

Louise Campbell conducted a Public Hearing in regards to the LWCF Grant application. There was no comment from the public.

Councilmember Barnhart made a motion to keep Resolution 2019-09 on the table; second by Jones. The vote was Ayes: Britt, Jones, Barnhart and Callahan.

Councilmember Barnhart made a motion to approve the minutes of November 13, 2018; second by Callahan. The vote was Ayes: Britt, Jones, Barnhart and Callahan.

Councilmember Jones made a motion to approve the minutes of November 20, 2018; second by Callahan. The vote was Ayes: Britt, Jones, Barnhart and Callahan.

Mayor Watson presented Resolution 2019-18 declaring property located at 488 Magnolia Street a nuisance. Councilmember Barnhart made a motion to adopt Resolution 2019-18; second by Britt. The vote was Ayes: Britt and Barnhart; Nays: Jones and Callahan.

Mayor Watson presented Resolution 2019-19 finding the property located at 488 Magnolia Street unsafe. Councilmember Barnhart made a motion to adopt Resolution 2019-19; second by Britt. The vote was Ayes: Britt, Jones and Barnhart; Nay – Callahan.

Councilmember Jones asked if she could reconsider and rescind her no vote for Resolution 2019-18. Councilmember Jones made a motion to reconsider Resolution 2019-18; second by Barnhart. The vote was Ayes: Britt, Jones, and Barnhart; Nay – Callahan. Councilmember Jones made a motion to adopt Resolution 2018-18; second by Barnhart. The vote was Ayes: Britt, Jones and Barnhart; Nay – Callahan.

Mayor Watson presented Resolution 2019-20 requesting the legislative delegation to pass an annexation bill. Councilmember Callahan made a motion to adopt Resolution 2019-20; second by Barnhart. The vote was Ayes: Britt, Jones, Barnhart and Callahan.

Mayor Watson presented Resolution 2019-21 authorizing the Mayor to enter into a consent settlement agreement in the pending litigation with G.B. Yates and Katrena Yates.

Councilmember Callahan made a motion to adopt Resolution 2019-21; second by Britt. The vote was Ayes: Britt, Jones and Callahan; Nay – Barnhart.

Councilmember Barnhart made a motion to authorize the Mayor to execute Change Order No. 3 in the amount of \$4,875.00 for the Mitchell Circle Drainage Improvements project; second by Callahan. The vote was Ayes: Britt, Jones, Barnhart and Callahan.

Councilmember Barnhart made a motion to authorize Barge Design to submit a proposal plan for Moseley Park improvements; second by Callahan. The vote was Ayes: Britt, Jones, Barnhart and Callahan.

There being no further business to come before the Council, Barnhart made a motion to adjourn; second by Jones. The vote was Ayes: Britt, Jones, Barnhart and Callahan.
